



OUTFITTER/CLIENT CONTRACT

LICENSE INFORMATION:

- *THE LAST FOUR DIGITS OF YOUR SOCIAL SECURITY NUMBER ARE REQUIRED BY FEDERAL LAW IN ORDER TO APPLY FOR A HUNTING LICENSES. ACCORDING TO WYOMING LAW, LICENSES ARE NOT TRANSFERABLE TO ANY OTHER PERSON.*

BOOKING CONFIRMATION:

- *TO CONFIRM A BOOKING, YOU MUST PAY A DEPOSIT EQUAL TO 50% OF THE TOTAL HUNT PRICE (PERSONAL CHECKS ARE PERMISSABLE FOR THE DEPOSIT). THE REMAINING HUNT FEES ARE DUE WHEN YOU ARRIVE TO HUNT AND MUST BE CERTIFIED FUNDS OR CASH (NO PERSONAL CHECKS).*
- *IF YOU ARE UNSUCCESSFUL IN DRAWING ON A SINGLE ANIMAL HUNT, YOUR DEPOSIT WILL BE RETURNED. IF YOU BOOK A COMBINATION HUNT AND ONLY DRAW ONE ANIMAL, YOU CAN REQUEST A REFUND ON THE PORTION OF THE DEPOSIT FOR WHICH YOU WERE UNSUCCESSFUL IN DRAWING AND BOOK AS A SINGLE SPECIES HUNT OR CANCEL THE ENTIRE BOOKING FOR A FULL REFUND.*
- *FAILURE TO DRAW IS THE ONLY REASON THAT DEPOSITS WILL BE RETURNED. LICENSE APPLICATIONS WITHDRAWN BY THE CLIENT WILL NOT COUNT AS FAILURE TO DRAW AND DEPOSITS WILL NOT BE ELIGIBLE FOR REFUND.*
- *ALL DEPOSITS WILL BE RETURNED WITHIN 60 DAYS OF NOTICE BY THE GAME AND FISH OF FAILURE TO DRAW.*
- *LICENSE FEES ARE NOT INCLUDED IN THE ADVERTISED PRICE OF ANY HUNT.*
- *RATE REDUCTIONS OR EXTRA DAYS WILL NOT BE GIVEN IF HUNTERS LEAVE BEFORE SCHEDULED CONCLUSION OF HUNT OR FAIL TO ARRIVE ON THE SCHEDULED DATES.*
- *CALL BEFORE BOOKING TO ARRANGE ALL STARTING/ENDING DATES AND DETAILS.*

PAYMENT METHODS:

- *FOR DEPOSITS WE ACCEPT: CASH, PERSONAL CHECK, CERTIFIED CHECK OR MONEY ORDER*
- *FOR REMAINING HUNT FEES, WE ACCEPT: CASH, CERTIFIED CHECK OR MONEY ORDER BUT **NOT** PERSONAL CHECKS*

GUARANTEE:

- *TO PROVIDE EXPERIENCED, KNOWLEDGEABLE, PROPERLY EQUIPPED GUIDES. TO DO OUR BEST TO ACCOMMODATE CLIENT EXPECTATIONS DURING THE HUNT. TO TREAT CLIENTS WITH RESPECT AND DIGNITY AND ENGAGE IN ETHICAL, FAIR CHASE HUNTING PRACTICES. TO PROVIDE A SAFE AND ENJOYABLE HUNTING EXPERIENCE.*
- *OUR GUARANTEE DOES NOT EXTEND TO THE FOLLOWING: INCLEMENT WEATHER CONDITIONS, MAINTENANCE OF YOUR HUNTING EQUIPMENT, YOUR PHYSICAL CONDITIONING, SHOOTING ABILITY, OR EYESIGHT. NOR DO WE HAVE ANY CONTROL OVER EMERGENCY SEASON CLOSURES.*
- *OUTFITTER MAKES NO GUARANTEES, IMPLIED OR OTHERWISE, THAT YOU WILL HARVEST AN ANIMAL(S) OR THAT HARVESTED ANIMALS WILL MEET ANY SCORING CRITERIA.*

WEATHER/LOST HUNTING OPPORTUNITY:

- *WEATHER CONDITIONS WILL HAVE A SIGNIFICANT POSITIVE OR NEGATIVE IMPACT ON YOUR HUNT. WE WILL DO OUR BEST TO HARVEST ANIMALS GIVEN THE WEATHER CONDITIONS. PLEASE BE ADVISED THAT NO EXTRA HUNTING DAYS OR REFUNDS WILL BE GIVEN DUE TO LOST HUNTING OPPORTUNITY FOR ANY REASON OR AREA/SEASON CLOSURES DUE TO WEATHER EVENTS. ANY ADDITIONAL COSTS FOR MOTELS, MEALS, TRAVEL, ETC DUE TO WEATHER ARE TO BE BORNE BY THE CLIENT.*

WOUND POLICY:

- *GUIDES WILL MAKE EVERY EFFORT TO TRY AND GET THE CLIENT WITHIN A REASONABLE RANGE OF AN ANIMAL TO MAKE A QUICK, ETHICAL KILL SHOT. IN THE EVENT THAT THE OUTFITTER/GUIDE DETERMINES ANY CLIENT HAS FATALLY WOUNDED AN ANIMAL, THE OUTFITTER/GUIDE WILL MAKE ALL REASONABLE EFFORTS TO RECOVER THE ANIMAL. IF THE ANIMAL CANNOT BE RECOVERED FOR ANY REASON, THE OUTFITTER WILL CONSIDER THE CLIENTS TAG AS FILLED FOR THAT SPECIES.*

LOSS DISCLAIMER:

- *THE OUTFITTER IS NOT RESPONSIBLE FOR ANY LOSS, DAMAGE, OR THEFT OF ANY ARTICLE OF A CLIENT'S HUNTING EQUIPMENT OR GEAR DURING THE HUNT.*

WAIVER OF LIABILITY:

- *ALL CLIENTS WILL SIGN A LIABILITY WAIVER BEFORE SHOOTING OR HUNTING ON ANY PROPERTY OWNED OR LEASED BY THE OUTFITTER.*

ALCOHOL AND ILLEGAL DRUGS:

- *THE CONSUMPTION OF ALCOHOL OF ANY KIND OR QUANTITY WILL BE STRICTLY PROHIBITED DURING THE HUNT. ANYONE WHO HAS CONSUMED ANY QUANTITY OF ANY ALCOHOLIC BEVERAGE WILL BE INELIGIBLE TO HUNT OR SHOOT FOR THE REMAINDER OF THAT DAY. CLIENTS ARE WELCOME TO RESPONSIBLY ENJOY ALCOHOLIC BEVERAGES AFTER THE HUNTING DAY HAS ENDED. NO ILLEGAL DRUGS ARE PERMITTED AT ANY TIME BEFORE, DURING, OR AFTER THE HUNT, OR ON ANY PROPERTY WHERE HUNTING ACTIVITIES OCCUR.*

FIREARM SAFETY:

- *IN ORDER TO PROVIDE FOR YOUR SAFETY, AND THE SAFETY OF YOUR GUIDE AND OTHER CLIENTS, THE FOLLOWING FIREARM SAFETY GUIDELINES WILL BE STRICTLY ENFORCED: 1) ALL FIREARMS WILL BE KEPT UNLOADED UNTIL YOU REACH THE HUNTING AREA OR UNTIL INSTRUCTED BY YOUR GUIDE TO LOAD YOUR MAGAZINE, 2) DO NOT CHAMBER A ROUND UNTIL INSTRUCTED BY YOUR GUIDE TO DO SO. ONLY CHAMBER A ROUND IMMEDIATELY PRIOR TO SHOOTING AT AN ANIMAL, 3) MUZZLE CONTROL WILL BE DEMANDED AT ALL TIMES. YOUR MUZZLE MUST NEVER POINT IN THE DIRECTION OF ANY PERSON, 4) BOLTS WILL BE OPEN WHILE IN THE VEHICLE, 5) ALL FIREARMS WILL BE CARRIED MUZZLE DOWN WHILE IN THE VEHICLE, 6) ABSOLUTELY NO SEMI-AUTOMATIC FIREARMS WILL BE ALLOWED.*

HUNT TERMINATION:

- *THE OUTFITTER MAY, AT HIS DISCRETION, TERMINATE A CLIENT'S HUNT AT ANY TIME IF THE CLIENT'S BEHAVIOR PRESENTS AN IMMINENT THREAT OR SAFETY RISK TO ANY PERSON. THIS APPLIES ESPECIALLY TO: 1) VIOLATION OF ANY OF THE TERMS OR CONDITIONS IN THE ALCOHOL/DRUG POLICY OR, 2) VIOLATION OF ANY OF THE TERMS OR CONDITIONS IN THE FIREARM SAFETY POLICY. SHOULD THE HUNT BE TERMINATED DUE TO VIOLATION OF SAFETY/ALCOHOL/DRUG POLICY, NO REFUND OF ANY AMOUNT WILL BE ISSUED, NOR WILL OUTFITTER BE RESPONSIBLE FOR ANY TRAVEL OR MOTEL EXPENSES.*
